



Terms and Conditions

World Life Experience "1st Edition 2017/2018"
By TOP EXPERIENCE Lda.

(General Conditions)

1. The Event World life experience is organized by Top Experience, Lda., headquartered in Av. Conselheiro Fernando de Sousa 19 16° Dto - 1070-072 LISBON also referred to in the current General Conditions as Organisation.
2. All rights to the event and the experience belong, unequivocally, to the Organisation.
3. Top Experience is the organizing entity of World Life Experience and has all rights over the content, the programme and the event model.
4. Top Experience is the event's promoter and owner of the international brand "World Life Experience", the intellectual property rights of the project and event designated by the brand's name.
5. Top Experience own the rights to images, copy and any product of the Event/Journey.
6. In case any unforeseen events or force majeure situations lead to delays and/or changes to the dates established for the completion of the World Life Experience event, and force changes on the General Conditions, the participant is not entitled to any type of indemnisation or refund.
7. In case the even World Life Experience does not take place, the Participant shall only be entitled to the refund of the value spent on the registration fee, without having the right to any type of indemnisation.
8. Top Experience has the right to alter or cancel the event in case of death.
9. Top Experience has the right to alter or cancel the event in case of kidnapping.
10. Top Experience has the right to cancel, change or not carry out the event if, for any unforeseen reason, the Event's security is compromised.

(Objectives)

1. WORLD LIFE EXPERIENCE is an innovative venture set up to create and foster a conscious community that will have a positive impact on the world and contribute to greater sustainability.
2. Promoting social responsibility through hands-on involvement with local organizations and global NGOs, raising awareness of the importance of sustainability in the world.
3. World Life Experience 1st Edition will take 12 wonderful people from opposite parts of the globe on an adventure through 25 countries, for a whole year. This is a unique experience. One in which each individual, though working as part of a team, will bring their own unique insight to this yet to be written story.
4. This is a private project that seeks to create stronger ties and greater cooperation between people, companies and non- governmental organizations geared toward social responsibility missions to generate better visibility and resourcing opportunities for social and humanitarian projects.
5. Top Experience is responsible, solely, for the content, information and application processes directly and exclusively connected with the official channels of World Life Experience.



6. The promoting entity is headquartered in Portugal, Europe and therefore any disputes must be resolved in the competent court of that country.

(Event Conditions)

1. World Life Experience reserves the right to implement changes to the travel plan or improvements, at any moment and without prior notice, as long as such does not imperil each participant's physical and psychological integrity, without the payment of any type of indemnisation whatsoever.
2. It is the Organisation's duty to define the rules to ensure the proper functioning of the event, namely those set forth in the regulation, at the site www.worldlifeexperience.com.
3. The Organisation shall take any measures it considers appropriate to ensure the attainment of the standards established, and, with that purpose, it may draft any additional amendments that may be deemed necessary.

(Applicant Profile)

1. The event is aimed at all individuals, regardless of nationality, between the ages of 20 and 35 who fulfil the basic requirements outlined in these regulations.
2. The applicant should be a good fit with the purpose of the project. More specifically, the applicant should be able to demonstrate throughout the different stages of application, that the basic requirements for application validation can be met. These include, but are not limited to:
 - a) Being communicative;
 - b) Proficient in English;
 - c) Possessing satisfactory physical aptitude for the structure of the event (medical certificate of health);
 - d) Having no criminal record;
 - e) Being legally entitled to live in their current country of residence.
3. There are six sought profiles as follows, and 2 candidates will be selected for each defined profile: EXPERIENCED (30-35 years old); ADVENTUROUS (25-35 years old); TRAVELLED (28-35 years old); ENTERTAINING (24-32 years old); VOLUNTEER (20-35 years old); STUDENT (20-25 years old).
4. The promoter's workers and employees, partners and sponsors, as well as spouses, family are not eligible to apply.
5. Applications should be submitted individually on the World Life Experience website: www.worldlifeexperience.com.
6. The selection process for participants will comprise three distinct application stages and applications will only be considered valid upon correct completion of all application forms.



7. Following the pre-application stage, the application will only be considered effective upon a payment of 9€ (nine euros). This will be the only payment the candidate will have to make throughout the entire project. This amount is divided thus: a donation of 2,50€ (two euros and fifty cents) to one of the NGOs chosen by the project and which the candidate will select; 4,82€ (four euros and eighty-two cents) for the selection process, and the remaining 1,68€ (one euro and sixty-eight cents) allocated to fees and taxes.
8. Only applications that meet the requirements included in these regulations and that provide the information requested in the forms shall be considered.
9. When completing the questionnaires, all of the information provided must be true. Applications containing any information which is found to be untrue, shall be excluded.

(Application Conditions)

1. When applying to participate in the project, applicants undertake to be available to participate in the World Life Experience for the duration of 1 year and to take part in activities related to culture, entertainment and social responsibility all over the world.
2. The applicant also agrees to be prepared to join a group of 12 people and to participate in a trip around the world.
3. The applicant is willing to share his/her experiences with the world through the World Life Experience communications channels.
4. All participants in the World Life Experience are obligated to complete the event in its entirety.
5. The 12 selected participants, will have to sign a standard working contract, that will be valid for the duration of the event.

(Financial Conditions)

1. All expenses in connection with the event are paid by the promoter.
2. All selected applicants are entitled to a monthly remuneration to all participants of 1.250€/month (one thousand two hundred and fifty euros) as payment for their participation in the activities and for sharing their experiences.
3. The holiday periods provided for within the scope of the project (one 15-day periods of rest each during the event for participants to return home).

1. Applications to enter the World Life Experience – 1st Edition 2017 event are open until June 15, 2017, 11.59 pm and this period may be extended for an additional 60 days.
2. Participants shall be announced no later than 30 days after the application period is closed.
3. If a 60-day extension of the applications is necessary, the event will begin on November 15, 2017.

(Application Process)

1. The World Life Experience – 1st Edition 2017 application process comprises 3 separate selection stages.
2. During each stage, applicants will be eliminated according to the selection criteria of each stage.
3. Participation in the event is only confirmed upon receipt of an official notice of confirmation of the final selection of participants, once all of the stages of application and selection have been completed.

(Pre-Application)

1. To participate in the World Life Experience event the candidates are required to complete a 1st registration form: (Expression of Interest to Participate) and accept these regulations.
2. The form will be made available exclusively on the official website at www.worldlifeexperience.com.
3. The registration will only be considered valid if all of the information requested in the form is provided, specifically: name; date of birth; email address and English level.
4. Once candidates have completed the registration form, all of the information provided will be stored and treated for selection purposes.
5. Once candidates submit the registration form, they will receive an email confirming that registration has been registered.
6. If candidates are eligible, they must follow the instructions provided in the email to continue their application process.

1. The applicants who are eligible in the Pre-Application must follow the steps corresponding to the Application in
2. order to continue as applicants. These steps will be included in the response email they receive from their initial Application, and consist of a more extensive form to be completed, and will require payment of the "application fee".
3. In the form, accessed in the reserved area at www.worldlifeexperience.com, they must complete the information regarding their personal data and select an NGO.
4. Completing the Application Form: (Formalizing application after pre-selection).
5. Of the Application Fee, 2,50€ (two euros and fifty cents) will be given to a NGO of the selected sector.
6. They must make the payment of 9€ (nine euros) through the means made available on the platform.
7. The information collected during this stage references specific data in view of the strict selection process of participants for the event. It includes a form with personal data; and a form with information on their profile.
8. Upon submitting the application, they will receive notice of their success in registering their application.
9. All of the information in the application will be stored and treated for the purpose of applicant selection. The data collected is for this exclusive purpose.

(Selection)

1. Only applicants who receive notice from the World Life Experience organization with the Application results, move forward to the Selection stage.
2. Applicants will receive the results of their application: "selected" or "Not Selected" addressed to the email provided on the form.
3. If they are selected, must follow the instructions contained in the email to continue in the selection process.
4. In this stage, some evidentiary documentation regarding the information provided will be requested and one or more interviews will be conducted with the applicant.

(Final Results of Participants)

1. All of the proposals received will be analyzed and scrutinized by a multidisciplinary team. This process is developed exclusively by an independent entity, CEGOC, Portuguese delegation, specialized in analysis, selection and recruitment.



2. The applications will be validated according to objective and subjective criteria and the regulations. Upon applying, the candidates explicitly guarantee to have read and agree with the selection criteria.

(Decision)

1. A total of 12 applications will be selected. Should an applicant withdraw or be unable to participate, the next applicant on the list shall be selected to take their place.

(Insurance)

1. All the participants will be insured for travel, work and medical assistance.

(Non-refundable clause)

1. The amount required to the application for the "*World Life Experience*", once paid is not refundable to the applicant at his request regardless of the claimed motives. Therefore, the application process becomes definitive and irreversible from the moment the application fee is paid.
